The Pledge of Allegiance was recited.

Mayor Hockenbury was out so Tammy Baker called for a vote for his replacement. Kenny Newton was voted in through secret ballot (3 votes), he will be the replacement for the remainder of the mayor's term should he be unavailable to attend a meeting.

Councilman and Acting Mayor Kenny Newton called the meeting to order at 6:32 p.m.

Council Members Stacy Cline, Lisa Carter, Bonnie Enlow, Mike Hibbard, and Deb Huffman were present.

Mr. Newton asked for a motion to approve the 05/23/2022 regular meeting minutes. Motion made by. 2nd by Ms. Carter. Motion carried 5-1. Kenny Newton abstained.

Mr. Newton asked for a motion to approve the 05/26/2022 special meeting minutes. Motion made by Ms. Enlow. 2nd by Ms. Huffman. Motion carried 5-1. Kenny Newton abstained.

NEW BUSINESS:

City Attorney Tammy Baker had the first reading and public hearing of Ordinance 022-055 Zoneton Developers amending the Bullitt County/City zoning map as amended, changing the zoning of 15.01 acres, more or less, located at 460 Buffalo Run Rd. in then City of Shepherdsville, Kentucky, also known as parcel 046-000-00-012 from B-1 Business to IL Light Industrial.

City Attorney Tammy Baker read resolution 22-19 relating to the Park Camera Project to be paid for with ARPA Funds for \$27,000.00.

Motion to approve made by Mr. Hibbard. Ms. Cline 2nd. Motion carried 5-1. Mr. Newton abstained.

City Attorney Tammy Baker read resolution 22-20 relating to the agreement between Commonwealth of Kentucky Transportation Cabinet Department of Highways and the City of Shepherdsville whereas the City of Shepherdsville is contributing \$100,000.00 in local funds towards the construction of sound barriers on the east side of I-65 across from Conestoga Industrial area from approximately Milepoint 117.400 to Milepoint 117.800 in the City of Shepherdsville.

Motion to approve made by Ms. Enlow. Ms. Huffman 2nd. Motion carried 5-1. Mr. Newton abstained.

City Attorney Tammy Baker read resolution 22-21 relating to purchasing a van for

\$25,000.00 for the Multi-Purpose Community Action Agency with ARPA Funds.

Motion to approve made by Ms. Enlow. Ms. Carter 2nd. Motion carried 4-1-1. Mr. Newton abstained. Ms. Carter voted no.

Public Works Director Tom LaFollette discussed the paving of Adam Shepherd Parkway and requested that he be able to put it out for bid estimating it will cost between 144,000 and 179,000.

Motion to approve putting a bid out in the newspaper made by Ms. Enlow. Ms. Carter 2nd. Motion carried 5-1. Mr. Newton abstained.

OLD BUSINESS:

City Attorney Tammy Baker had the second reading of Ordinance 022-054 an ordinance amending ordinance 01-283 and ordinance 019-299 and adopting a Personnel and Pay Rate Classification Plan for City Employees and Non-Elected City Officers for the City of Shepherdsville, Bullitt County Kentucky.

Motion to approve made by Ms. Enlow. Ms. Carter 2nd. Motion carried 5-1. Mr. Newton abstained.

SIGN IN SPEAKERS:

Valerie Moore spoke about the conditions of her neighbor's yard and the sandbags stacked up around his house and stated that the smell and mosquitoes were causing many issues for she and her husband. The council discussed it a bit further. No conclusion at his time.


RETURN TO REGULAR SESSION


Motion made by Ms. Huffman. 2nd by Ms. Cline. Motion carried 5-1. Mr. Newton abstained. Time: 7:53 pm.
