CALL TO ORDER

With an invocation by Councilwoman Mike Miller, and the recital of the Pledge of Allegiance, Mayor Hockenbury called the meeting to order at 6:31PM.

PRESENTATION:

Mike Miller with Family Day Ministries took the podium and discussed what he and his church would like to do with the homeless problem in Shepherdsville. He explained that they would like to have a 48-hour emergency type turnaround program that they could take in the homeless, feed them and let them shower and transport them to a place in Louisville that will help them obtain jobs and housing. He asked if the council would support this endeavor – not financially - the council asked questions, all appeared to like the ideas presented. Mr. Miller stated he would come back when the new Mayor and Council were in place in January and discuss it again. The Mayor and Council thanked him.

A. TAMMY BAKER DID THE FIRST READING OF ORDINANCE 022-073 REPEALING ORDINANCE 019-283, ORDINANCE 019-296 AND ORDINANCE 019-299, AND ADOPTING A PERSONNEL AND PAY RATE CLASSIFICATION PLAN FOR CITY EMPLOYEES AND NONELECTED CITY OFFICERS FOR THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY.

Bonnie Enlow stated that they had no idea this was being put on the agenda. Lisa Carter asked who sponsored this ordinance. Bonnie then stated that they did not finish this and did not approve it. She said an employee obviously put it on there – that they didn't do it.

Tammy Baker said that they could put it on the next agenda for the next meeting and it could be tabled then if they chose.

Bonnie Enlow said she wanted to make it clear that employees don't have a right to put an ordinance on the agenda, that it is the council members that sponsor those and that they were the three that were on that committee and none of them sponsored that.

Mike Hibbard made a motion to table the civil service ordinance because he didn't know how long it would be to get the information he requested and to discuss and analyze it.

Bonnie Enlow stated that they did agree at the last meeting that they were going to take out incentives, and to approve the Fire Departments part of this.

Layne Troutman stated that he needed it done to get the department back to the operational status they once were, because they had lost command staff.

Lisa Carter stated that they agreed at the last meeting to do that?

Bonnie Enlow said yes, they had agreed to get rid of the incentives and pass the Fire Department Job Classifications and Pay Scale.

Mayor Hockenbury asked if they wanted to wait for the new council. They stated that they didn't, that it needed to be done.

Tammy Baker asked if it was possible for the committee to meet between now and the next meeting to determine if the ordinance's read tonight is appropriate to move forward.

Mike Hibbard said it depended on when they get the information requested.
